In order to facilitate career guidance and counselling for prospective learners, the University will establish Information & Career Counselling (ICC) Centres at different locations and an agreement will be signed Between Desh Bhagat AND authorized individual/Organization operating Information & Counselling (ICC) Centres as per **Annexure – I.**

	b)	Conduct all admissions, fee collection, course delivery, LMS		

access, evaluation, examinations, and degree issuance directly through DBU's official systems, as per UGC guidelines.

c) Train ICC representatives periodically on counselling and compliance requirements.

d) Monitor, audit, and evaluate ICC operations to ensure compliance with UGC guidelines.

2.2 Responsibilities of ICC Partner

- a) Provide counselling and guidance only to prospective students about DBU programs.
- b) Display prominently at the ICC premises: "Information & Career Counselling Centre (ICC) Advisory & Guidance Only.
- c) Refrain from:
 - Conducting classes, tutorials, or coaching.
 - Collecting any fee or payment from students.
 - Distributing study material or conducting examinations.
 - Using the term "Study Centre," "Franchise," or any similar designation.
- d) Refer all admissions, payments, and academic processes to DBU's official CRM/portal.
- e) Maintain professionalism and ethical standards in counselling.
- 3. Financial Terms: ICC Partner shall not charge any student directly for admission, tuition, study materials, or examinations.

4. Legal Compliance

- a) The ICC Centre shall operate strictly as per UGC (ODL & Online Programmes) Regulations, 2020 and subsequent amendments.
- b) Misrepresentation, misconduct, or violation of this MoU shall empower DBU to terminate this agreement with immediate effect.

5. Duration & Termination

- a) This MoU is valid for a period of three (3) years from the date of signing, unless terminated earlier by DBU for non-compliance.
- b) Either party may terminate this MoU with 30 days' written notice.

6. Dispute Resolution

- a) Any disputes arising under this MoU shall be subject to amicable settlement.
- b) Failing settlement, the matter shall fall under the jurisdiction of courts at Fatehgarh Sahib, Punjab, India.

7. Confidentiality

Both parties agree to maintain confidentiality of student data, admission information, and DBU's internal policies.

- 8. General Provisions
 - a) This MoU does not create any employer-employee relationship between DBU and ICC Partner.
 - b) ICC Partner shall use DBU's name/logo as permitted under this agreement.
 - c) Any modification to this MoU must be made in writing and signed by both parties.
